ICO updated SAR (Subject Access Request) guidance

The right of access is a cornerstone of data protection law and good SAR compliance instils trust and confidence. The Information Commissioner's Office have recently released updated guidance, which you can read here: https://ico.org.uk/for-organisations/guide-to-data-protection-regulation-gdpr/right-of-access/information-about-other-individuals/

In summary, the main updates to the guidance are:

- 1) Stopping the clock for clarification
- 2) Consideration of what is a manifestly excessive request
- 3) What can be included when charging a fee for excessive, unfounded or repeat requests update on what organisations can take into account when charging an admin fee.

Data Sharing agreements on the ISG (Information Sharing Gateway)

I have recently reviewed and approved the DPIA (Data Protection Impact Assessment) for the <u>Tele-dermatology service</u> in Oldham. This should be on the ISG for data controller signoff.

I have also reviewed the DPIA for the rollout of the <u>Elemental system</u> for use by Social Prescribers in Oldham and I think the system will work well in conjunction with EMIS. I flagged just a couple of concerns with the DPIA and once these have been addressed, the final version will be uploaded onto the ISG.

I have also been involved in the development of the GM Care Record <u>COVID 19 university</u> <u>research</u> DPIA. This has now been approved and will be on the ISG for sign-ff by data controllers in Tameside & Glossop and Oldham.
