LMC meeting – 8th February 2022

The committee met on the evening of Tuesday 8th February 2022 via Teams. We were pleased to welcome Vanessa Morris who has taken on the Oldham Practice Manager Representative role, job sharing with Andrea Morrison. We also welcome Dr Ismail Ahmed who will be taking on the role of First Five Representative for Oldham going forward. The GM Care Record was discussed, with some committee members flagging that they don't feel the Communications campaign has been farreaching enough. Dr Alan Dow, LMC Secretary, suggested that his patients are largely unaware that their data is flowing into the GMCR Repository, and he is particularly concerned that his patients won't realise that their health data could be shared with the GM councils. He also suggested that the GMCR data isn't particularly useful for GPs, the data from secondary care providers doesn't provide any useful information such as the actual letter content. The committee went on to discuss the new QOF requirement regarding Child immunisations, which is a very tight target, without exceptions. For smaller practices it could be a challenge to achieve if a child/parent refuses vaccinations. It was acknowledged that this requirement puts smaller practices at an unfair disadvantage and the LMC agreed to flag this with the appropriate parties. Dr Alan Dow, GM GPC representative was able to flag the issue with the GPC (the GP Committee of the BMA) at their meeting this week.

DPO Update

"COPI NOTICE " extended to June 30th, 2022

On 9th February 2022, it was announced that the COPI Notice (Notice under Regulation 3(4) of the NHS Control of Patient Information Regulations 2002) has now been further extended until June 30th, 2022. The COPI Notice provides a temporary legal basis and mandates the sharing and processing of patient data with a Covid-19 purpose. For the purpose of editing your privacy notice, I will send you a copy of the renewed Notice when that becomes available.

NHS Digital DARS – (Data Access Request Service) - NIC-388913-L5D5B-v2.6)

As you will be aware, to support the response to the Covid-19 pandemic, NHS Digital has been directed to collect and analyse healthcare data, by collecting patient data from the GP record for the duration of the COVID-19 emergency period. The "COPI Notice" is the legal basis for this work. For your records, I have attached a copy of the updated Data Sharing Agreement, which now also includes the Vaccination and ethnicity data.

Medical Examiners

From April 2022 Medical Examiners will be scrutinising all non-coronial deaths and it will be a statutory requirement for GP data controllers to allow the Medical Examiner team to access the patient records. Although the deceased don't come into the scope of the Data Protection legislation, we felt it was appropriate to conduct a DPIA (Data Protection Impact Assessment) as the Medical Examiners will be given full access to the clinical system and will require Next of Kin data. DPIAs/ Data sharing agreements will be shared with GP Data controllers via the Information Sharing Gateway in due course. In the meantime, I have attached some slides, which you may find useful.

NHS England Accelerating patient access to health records via NHS App

This programme, which will enable patients over the age of 13 to access the prospective data in their health record via the NHS app is due to be implemented from April 2022.

NHS E shared an update last week, a summary of which I have attached for your information. I was pleased to read that, further to pressure from IG professionals, they now intend to conduct a full DPIA (Data Protection Impact Assessment).

Safeguarding Leads from across Greater Manchester have written to the implementation team outlining their very significant concerns from a safeguarding perspective. The response from NHS E said they would welcome collaborative working with the safeguarding leads, but also made it very clear that the implementation date will still be April 1st, 2022, for EMIS and TPP users.

I have reattached the concise guidance document I have compiled, which lists the risks and contains instructions on redacting specific data items, as a way of mitigating these risks. It also contains instructions on how to set up prospective access on the clinical system. Data sharing agreements relating to the GP Practice data flowing into the GM Care Record are detailed below. Information Sharing Gateway/ GDPR Article 30 requirement

Article 30 of the GDPR dictates that all Data Controllers should have an up-to-date "ROPA" (Register of Processing Activities). The Information Sharing Gateway is a good reference library for tracking data flows in and out of your practice.

- Cievert Covid vaccination appointment booking system for all practice in Tameside & Glossop and flu vaccination booking for Hyde & Stalybridge PCN practices
- My Way Diabetes a platform to enable improved self-care by diabetic patients
- GM Care Record Direct Care
- GMCR cloud migration
- GM Care Record Business Intelligence
