West Pennine LMC meeting - Tuesday - February 2024

The committee met on Tuesday 13th February via Teams. Representatives discussed the marked increase in measles infections and the associated challenges, including the recommendation that clinicians should be fit tested for FFP3 masks, something which is not currently funded. Mark Lowton, Tameside Practice Manager representative, flagged that there have been eleven suspected cases at his practice in Denton in the last week and, having sent off swabs to Tameside Hospital, only one result has been returned. The LMC has flagged this system failure with Manisha Kumar, GM ICB Clinical Lead and it is being dealt with as a matter of urgency. The committee went on to discuss the Medical Examiners programme and the fact that the draft regulations may become statutory requirements from April 1st, 2024. Mark Lowton, Tameside Practice Manager representative, flagged that the removal of the EMIS panic button, potentially leaves GPs and clinicians in a very vulnerable position. The LMC is to look into alternatives to the EMIS panic button and will also look into the possibility of hosting conflict resolution training for GPs and their teams.

Medical Examiners update

From April 2024, the current draft regulations regarding Medical Examiners may become a statutory requirement. As you will be aware, the Medical Examiners are to give additional scrutiny to the reporting process for non-coronial deaths.
