LMC meeting – May 11th, 2021

The committee met on the evening of May 11th via Microsoft Teams. We were delighted that Kay Keane from the Institute of General Practice Management was able to join the meeting as Guest Speaker. Kay explained how she and three other Practice Manager colleagues have set up IGPM in an effort to support Practice Managers and recognise the essential role they play in General Practice. She shared that a formal qualification for Practice Managers is being developed. <u>IGPM – Institute of General Practice Management</u>

In his capacity as GM GPC representative, Dr Alan Dow had attended the BMA-LMC conference earlier in the day. Dr Amir Hannan had also attended as a representative of West Pennine LMC and they shared a summary of the conference and the issues being discussed at a national level. The committee went on to discuss the ICP contract, direct reimbursement to practices in Oldham and Tameside & Glossop, Spirometry and QOF, and letter requests from Tameside Live Action. There was also a discussion around patient demand and system capacity and the ongoing inappropriate transfer of work from secondary care to General Practice.

COVID 19 guidance

Tameside & Glossop CCG have published version 25 of their Covid 19 guidance. Please find the attached document. The only change this month is the addition of the guidance on when prescribing inhaled budesonide, which might be appropriate for patients for helping to resolve COVID Sx (within 14 days of onset). It is the lilac box in the centre.

Advice on death reporting

The GM Corners recently published updated guidance on death reporting in relation to Coronavirus Act 2020, which we have attached. We have also attached the Notification of Death guidance 2019 and the guidance from the Royal College of Pathologists on death reporting which you may find useful.

Direct reimbursement to GP Practices

Dr Alan Dow, LMC Secretary, recently met with Richard Maddocks, Community Health Partnerships Property Finance Manager for the Oldham Area, to discuss direct payments to GP practices going forward. The LMC generally support this approach and feel it would be beneficial for GP practices, removing the time involved in managing the current bureaucracy. Direct payments have the backing of DHSC and NHSE. Anyone wishing to implement this is advised to first discuss the process with one of the LMC officers and consider the extent of their existing arrangement/ contract with NHSPS/ CHS.

Proposal by GMSS to access GP Practice s in Oldham using smart cards

Andrea Hughes, Oldham CCG IG Manager, flagged this proposal at last week's Oldham PM forum and she has requested that you contact her to let her know that you, as data controller, are happy with the arrangement andreahughes3@nhs.net

Andrea and I have reviewed the associated DPIA, and we are satisfied that the proposal meets all relevant Data Protection and Information Governance requirements.

NHS Digital GP Practice data Collection for planning and Research

NHS Digital has been directed to collect, process, analyse and disseminate general practice data to support the purposes set out in the <u>GP Data for Planning and Research Direction</u> 2021.

You may have already received an email from EMIS/ TPP, requesting that you activate the data sharing agreement for the NHS Digital Data collection for Planning and Research.

Patients have a right to opt out of their data being shared by registering a <u>Type 1 Opt-out</u> or a <u>National Data Opt-out</u>, or both. It is likely that the majority of patients are unaware of NHS Digital's initiative and I therefore advise you to contact your patients, perhaps via an AccuRx or Mjog text message, to highlight their options and reassure them that opting out using either option will not affect the individual care received from their GP practice. The data collection is due to start on 1st July 2021, so patients would need to opt out by 23rd June 2021.

Data Sharing Agreements on Information Sharing Gateway

There are some data sharing initiatives on the ISG, which are still awaiting data controller sign off. It would be much appreciated if you could check the ISG, and please do let me know if you have any queries.

The following DPIAs have been recently uploaded onto the ISG for data controller sign off. In both cases, I have scrutinised the DPIAs and am satisfied that these data sharing initiatives meets all relevant data protection and Information Governance requirements.

For practices in T&G:

Willow Wood – GP Practices

This is to enable bidirectional read only data sharing for Willow Wood hospice and the GP practices in T&G.

For practices in Oldham:

UEC by appointment

In response to the Urgent Care by Appointment initiative, the CCG are currently commissioning a Primary Care Led Urgent Care Service from the Integrated Care Centre (ICC) in Oldham and a Pre-ED Rapid Assessment at The Royal Oldham Hospital A & E Department.

My Way Diabetes - update

Further to last month's update, I have ongoing concerns about the My Way Diabetes data sharing agreement, particularly around the proposed EMIS bulk upload. The project team's justification for extracting data for <u>all</u> diabetics is that they need to populate the "My Way clinical platform", which is to be used by clinicians and GPs. I pointed out that most GPs would prefer all clinical information to be contained in their clinical system and it's unlikely that a separate app would be utilised. The proposed initiative is now being looked at by Dr Tracy Vell and Guy Lucci from the GM NHS Innovation team and I advise you not to engage with the My Way Diabetes project until further notice.
